Members of the family of mission leaders, members of senior management, diplomats and senior officials who enjoy the same status as the main accredited person (owner of a "B" or "C" legitimation card) can obtain free access to duty-free shop showing the "customer card" granted to the main accredited person Members of the family who accompany a foreign delegate or an expert on mission with diplomatic status may have access only to the duty-free shop if accompanied by the delegate or an expert authorized to use it. People who have the right to access the duty-free shop (according to the above definition) must show their legitimation card at any time. In their first visit will be issued a personalized "customer card". In the future, it must be shown along with the legitimation card when entering the store and at the time of payment. Foreign delegates and mission experts must show their identification whenever they enter the shop. on the first occasion, a form entitled "authorization of access to the duty-free shop of Geneva" (No. 14.65). the module is provided to foreign delegates by the Secretariat of the International Conference participating and, in the case of experts, by the international organization to which they are responsible for a particular mission. the module must be completed and certified by the international organization that provides it. international organizations can get the form from the management of Geneva customs (see details below). access to duty-free shop and purchase of duty-free items is a non-transferable right reserved for those eligible as described above. with the exception of a member of the family who has the right to access the duty-free shop (see "family members,") can not be represented by a third (such as a private servant, another member of the organization, etc.). Moreover, eligible persons must comply with the duty-free shop rules and submit to the control procedures introduced with the consent of the Swiss authorities. merchandise except fresh or frozen food, the product range is wide and the assortment is adapted to the supply and demand. the following goods may be purchased in the quantities specified during each quarter for the main beneficiary : alcoholic beverages exceeding 25°: 50 liters wine, champagne: 300 liters drinks of less than 25°: 60 liters Cigarettes: 7'000 units The quarterly periods mentioned above correspond to the terms at the end of March, June, September and December. The purchase of quantities greater than these maximums is not allowed in the same quarter. Nor is it allowed to claim a portion of the quota of the next quarter or the unused part of the previous quarter. Eligible persons may, at any time, easily verify the quantity of goods to which they are still authorized in the current quarter in the duty-free store. The goods purchased through direct import, in particular by commercial firms specialized in the provision of beneficiaries of diplomatic privileges and duty-free immunity, are not subject to such regulations. The resale or transfer of items purchased at the duty-free shop, with or without payment, is strictly prohibited by the current legislation. The Bern Department of Foreign Affairs (DFA) reserves the right to take measures against persons who do not comply with their obligations in this regard or with the conditions in which access to duty-free shop is granted.
